## Dennis' Moment Update From Wyoming

In 2023, CJ Thoroughbreds and Eugene Joyce of Wyoming acquired Dennis' Moment and relocated the Kentucky-bred Thoroughbred to stand in Wyoming beginning in the 2024 breeding season.

Dennis' Moment is doing very well, and in fact, he's thriving in Wyoming. In his first year as a stallion, Dennis was a quick and eager learner. The farm management team comment that he has a calm, easy going demeanor and he's extremely cooperative in the breeding shed.

From the 2024 breeding season, there are 14 Thoroughbred mares in foal to Dennis, his first crop, and all Wyoming-breds.

In July, Dennis' Moment and our mares were relocated from Golden Creek Equine in Cheyenne to a new farm operation, also in Cheyenne, which is owned and operated by Dave and Cindy DeLancey, well-known and respected horsemen in Wyoming.

In addition to being an accredited Wyoming Thoroughbred stallion, Dennis' Moment has been registered as a stallion with the American Quarter Horse Association as we explore breeding opportunities for Appendix Quarter Horses, including shipped semen.
